Through internet, emails and letters, the 100 year prayer meeting is being continued. Corrie ten Boom Fellowship has over 2 million people joining in prayer as part of the ongoing prayer meeting to pray for Israel and over 710,000 people are part of the Jerusalem Prayer Team, adding over 305,690 new prayer partners in 2014. During 2014, the organization's social media fan base grew by 163,000, Facebook followers increased to 322,776, articles and posts received 4,268,650 "likes", 956,440 "shares", and 319,398 "comments". Additionally, the organization conducted meetings & prayer gatherings in churches in the U.S.

The organization educated prayer partners through many educational products, including 5 newly published books and 3 older books updated. Additionally, "Born Again, 1948" book was translated into Hebrew. The "Hiding Place" Virtual Tour was viewed by 145,562 people online in 20 languages (www.tenboom.com). Several educational television specials were aired throughout the U.S.A., and the organization continues to combat anti-Semitism. Through grants, the organization has helped build the Friends of Zion Museum (formally Friends of Zion Heritage Center) located in Jerusalem. It will be completed in April, 2015. It will educate about what Christian Zionists have done through the years and sacrifices made by Christians for the sake of Jews and Israel, especially during World War II.

Through grants, Corrie ten Boom Fellowship fulfilled several humanitarian projects in Israel, including assistance with food coupons for impoverished Holocaust survivors during Passover and other times during the year. Funds also provided continual support to maintain and improve the restored bomb shelter - community center for impoverished Holocaust survivors in Jerusalem and apartments in Haifa to provide housing to Holocaust survivors.
