Through the internet, and via emails and letters, the 100 year prayer meeting is being continued. Corrie ten Boom Fellowship (CtBF) has several million people joining in prayer as part of the ongoing prayer meeting to pray for Israel. In 2017, over a million people are part of the Jerusalem Prayer Team.

CTBF's social media fan base and Facebook followers grew to 31,613,870 by the end of 2017. CTBF posted 6,149 articles and inspirational messages on the Jerusalem Prayer Team's Facebook site. The posts received 214 million "likes" (reactions to posts), 26.7 million "post shares" and 23 million "comments" in 2017. Additionally, the organization conducted meetings and prayer gatherings in churches in the U.S.

4b (Code:) (Expenses \$ 1,345,248 including grants of \$ 1,050,000) (Revenue \$)

Corrie ten Boom Fellowship educated prayer partners through many educational products, including five newly published books: "Jew Hatred and the Church", "The Visionaries", "Jerusalem D.C. Israel Reborn", "Why Was I Born?", and "Son, I Love You". Additionally, "Christian Zionist Vol. 1", and "Friends of Zion Museum Book" were translated into Hebrew.

The "Hiding Place" Virtual Tour was viewed by 33,719 people online in 20 languages (www.tenboom.com). Several educational spots on social media and on TV that was about the Holocaust survivors were aired throughout the U.S.A., and the organization continues to combat anti-Semitism.

Through grants, the organization helped to build and operate the Friends of Zion (FOZ) Museum and Friends of Zion Heritage Center located in Jerusalem

Through grants, Corrie ten Boom Fellowship fulfilled several humanitarian projects in Israel, including assistance with food coupons for impoverished Holocaust survivors during Passover and other times during the year. Funds also provided continual support to maintain the restored bomb shelter - community center for impoverished Holocaust survivors in Jerusalem, and apartments in Haifa to provide housing to Holocaust survivors.
