In 2021, over a million people were part of the Jerusalem Prayer Team. CTBF's social media fan base and Facebook followers was 31,246. CTBF posted 4,544 articles and inspirational messages on the Jerusalem Prayer Team's Facebook site. The posts received over 37 million reactions to posts & 2 million Shares, & 4.5 million comments in 2021. Meetings & prayer gatherings were conducted in churches & homes in the U.S.
